| Welcome & Introductions  | Great group of 11 people making a great start.  |
| History of the Alliance Against Heroin   | <p><u>Previous meeting on Dec 16, 2014</u> = 20 participants attended meeting to learn more about the vision of the Alliance and the 5 Pillar Approach. The Recommendations that go with each Pillar was overwhelming so there was discussion about Recommendations already being done in Sheboygan County and could be done in Sheboygan County. There was no follow-up meeting due to lack of planning and initiation by MaryAdele Revoy, but the email distribution list of over 30 people still exists.</p> <p><u>Survey of volunteers in January 2015</u>: MaryAdele sent out a survey to all members on the distribution list and received 12 completed surveys. People got to pick those recommendations they would like to work on or were already involved in. In relation to the current CHIP plan that was passed out, the number of volunteers for that "signed up" in January was:</p> <ul style="list-style-type: none"> <li>• Take Back Day – 8 volunteers</li> <li>• Education on the use of the Statewide database for prescriptions – 6 volunteers</li> <li>• Town hall meetings/public education events – 13 volunteers</li> <li>• Track of naran use – 3 volunteers</li> <li>• Workplace issues &amp; policies – 5 volunteers</li> <li>• Network of treatment providers – 4 volunteers</li> </ul> |
| Restructuring to fit the new HSC2020 MH/SA Committee   | This subcommittee is part of the larger Mental Health Substance Abuse (MHSA) Committee. Would like to formally name the subcommittee the "Alliance Against Heroin" to give it a bit more "strength" and marketing capability – just sounds better. As part of being under Healthy Sheboygan County 2020 and the MHSA committee, all work should have an underlying focus on : (1) education/prevention; (2) access to service; (3) coordination/continuum of care; and (4) health literacy.   |

Workplace                    | <ul style="list-style-type: none"> <li>c) An infographic on the connection between prescription pain abuse and risk of heroin use; again great infographic; could be replicated with stats about Sheboygan; stats can be found in the County Call to Action report.</li> <li>d) A write up about the Prescription Drug Drop off program in Sheboygan County included history of the program, statistics on how many pounds of material have been collected, and the WI Prescription Drug Monitoring Program (PDMP). It was noted the PDMP statewide database has 2,084 WI doctors registered with over 10 MILLION prescriptions entered by the end of 2014. The quantity of pills prescribed was close to 13 BILLION and the estimated days' supply was over 237 MILLION by the end of 2014. The database was able to decrease the number of "doctor shopping" by 26%, so it is working. For Sheboygan County, the number of doses per person was 29 based on county population numbers from 2012.</li> <li>e) Draft copy of the CHIP plan regarding Heroin – not included in email.</li> </ul> |
