Clinic/Hospital Implementation	Shelby reported that she informed Dr. Richard Brown of the Aurora statistics that were run to
<ul> <li>SBIRT Training – Richard Brown</li> <li>SBIRT and the Schools</li> </ul>	include Medicare data on annual preventive exams, of which 24,000 were performed in 2015. He recommended that one "coach" be trained in SBIRT for every 4,000-6,000 patients screened. Shelby did inform the Aurora Leadership team of this, and has not heard back. Kristin will reach out the Aurora Leadership Team and Dr. Murthy will reach out to Dr. Gavin. Mary reports that she and Paula did meet with Dr. Gross within Prevea who is interested in SBIRT screening within Prevea. Kristin, Paula and Mary will meet in August at the quarterly meeting of Prevea Providers. Shelby will share the recent power point she created for a similar meeting she recently had. She said she has heard that some CPT codes are failing to receive the reimbursement. Kristin will email Mia regarding this problem. The CPT code will yield more income especially for non-professional staff who do the screening.  Kristin reports that Lakeshore has recently hired a manager for the Manitowoc Clinic and she has done SBIRT in a correctional facility.  Cindy, Ann, and Mary will work on setting up an SBIRT training (possibly in September) geared at Health Clinics with Richard Brown presenting.  Jon is in the process of setting up a meeting with Quynh Trueblood, the Kohler school superintendent regarding the SBIRT training process. He will contact Cesa 7 to see if they would be willing to come to our August 17 <sup>th</sup> SBIRT meeting to educate us on the SBIRT training they
