They also aren't sure what they're doing when their grant is over this year. However, they do know they will still be providing training, but there will be a cost. (cost to be determined). Shelby was told to get in contact with Scott Caldwell who is the SBIRT contact for DHS with the State. She has left voice messages and so far has not heard back.</li> <li>Shelby has still been in contact with Mia Crowl. Mia informed her that once someone has completed the training, they will never need to re-educate or update their training. Right now that initial training is the barrier, it is not yet a common code for insurance companies, and there are no grants in Wisconsin for the 60 hour training at this time. The 60 hour training is actually only 30 hours of face-to-face training. The other 30 hours is other, hands on training. Dr. Brown has a local company that offers training at no cost at this time. In general, the training process is not very clear. There are no options to train the trainer, and there is not a separate training for healthcare professionals. It is the same training for all settings.</li> <li>Public Health is looking into if they have more of an outreach to find or provide training. Right now there is a 4 hour training on the DHS website.</li> </ul>

	<ul> <li>everyone at the same time, having a deadline for completion, and making the email message as uniform as possible. There will not be a different version of the survey for schools. It was decided that peer-to-peer contacts would be the most effective way to see more survey results. Libby will reach out to Aurora, St. Nick's, and Prevea, and Tom Malmstadt with the Random Lake School District about having the survey sent to their peers internally.</li> <li>The group decided there are too many narrative responses in the current version of the survey. It cannot take too long to complete the survey because people will not be willing to complete it. Dr. Murthy agreed to look at the current survey and come up with multiple choice answers that would apply to healthcare providers. Dr. Murthy also noted the survey shouldn't be sent to all medical providers. It can be sent mainly to primary care doctors, but the group decided that it would be up to the discretion of the health systems of who they decide it would be best to send to.</li> <li>When the surveys are sent out, either CC hsc2020@sheboygancounty.com so Libby can see who it was sent to, or let Libby know how many people the survey was sent to. The goal of the survey is to find out how often SBIRT is being used in Sheboygan County.</li> </ul>
